Section 4 First Aid Measures

Section 6 Accidental Release Measures

Clean Up Methods: For small spills absorb liquid on vermiculite, floor absorbent or other absorbent material. For larger spills eliminate all ignition sources (flares, flames, including pilot lights, electrical sparks). Persons not wearing protective equipment should be excluded from area of spill until clean-up has been completed. Stop spill at source. Prevent from entering drains, sewers, streams or other bodies of water. Prevent from spreading. If runoff occurs, notify authorities as required. Pump or vacuum transfer spilled product to clean containers for recovery. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal. Prevent run-off to sewers, streams or other bodies of water. If run-off occurs, notify proper authorities as required that a spill has occurred.

Section 7 Handling and Storage

Handling: Avoid prolonged skin contact. Do not breathe spray mist. Ground containers when pouring and limit free-fall to a few inches to prevent static sparks. Avoid spontaneous combustion of contaminated rags or other easily ignitable organic accumulations by immediate immersion in water. Emptied containers may retain hazardous properties. Do not cut, puncture or weld on or near the container.

Storage: Store away from heat, sparks and open flame
